Donor	Rs. 11,000/- or more one time
Patron Member	Rs. 8,000/- or more one time
Life Member	Rs. 6,000/- or more one time
Ordinary Local Member	Rs. 800/- per year
Ordinary Outstation Member	Rs. 600/- per year

In view of the same, this Renewal Form is sent to you under the amended constitutional provision.

In case you intend to convert your membership from "Ordinary" to "Life" then you will be required to pay Rs. 500/- towards fees for conversion from Ordinary to Life category in addition to the fees as mentioned in para hereinabove. You will also be required to fill up the fresh Membership form which can be obtained from Association's office.
